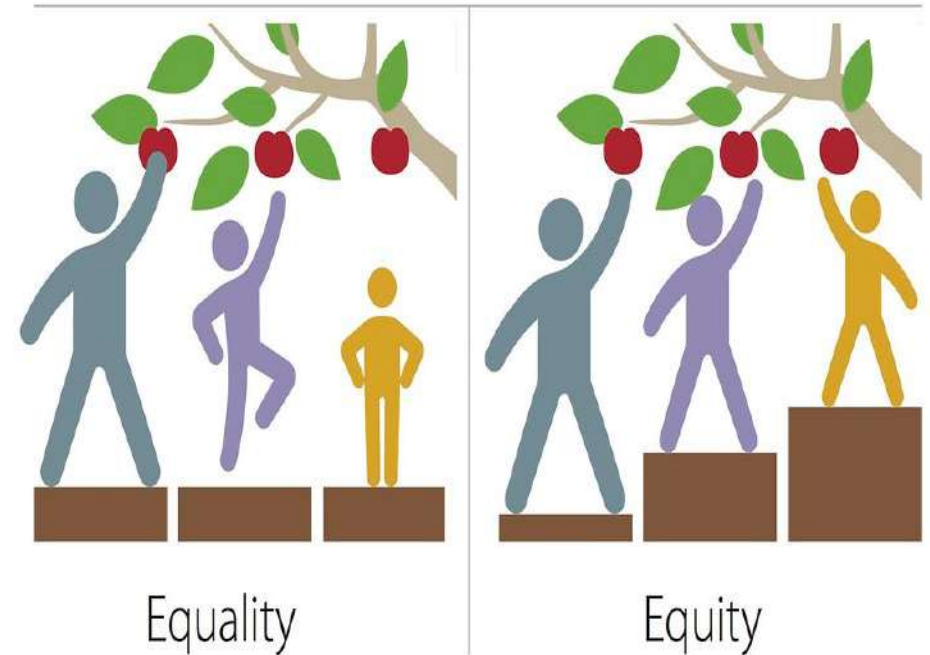


Workgroup Updates

Michigan Early Childhood Courts Priority Population Disparity Impact Statement (DIS)

- Children prenatal to three years of age and their caregivers who are in the child welfare system due to lack of equitable services and health disparities.
- We intend to identify the root causes of racial disparities in child welfare, including access to health and mental health care.
- We will focus on addressing health equity and racial disparities in access to and receipt of behavioral health services.

DIS Goals



Explore front end redesign of infrastructure by reviewing social determinants of health and equity to ensure equitable access to effective services that promote well-being and protective factors for children prenatal to three and their families.



Enhance the quality of services and support provided to families and promote the overall health and well-being by identifying opportunities for improvement and ensuring alignment with their needs.



Improved understanding of disparities in access to medical and behavioral health services and developmental screenings.
